# HATFIELD BOROUGH COUNCIL REGULAR MEETING April 17, 2019

#### MINUTES

#### CALL TO ORDER AND ROLL CALL:

The record shows that three members of Council were present at roll call, as well as, Mayor Robert L. Kaler, III, Solicitor Catherine M. Harper; Timoney Knox LLP, Borough Manager Michael J. DeFinis and Assistant Manager Jaime E. Snyder.

Solicitor Harper stated that on Action item 8B, SEPTA did not get the Borough the lease agreement so this can item can be removed from the Agenda.

#### 1. APPROVAL OF MEETING AGENDA:

Motion: A motion was made by Councilmember Stevens to

Approve the Regular Meeting Agenda of April 17, 2019 with corrections and additions. The motion was seconded by Councilmember Kroesser and unanimously approved

with a vote of 3-0.

## 2. Public Hearing Regarding the Verizon Cable Franchise Renewal:

PRESIDENT JOHN WEIERMAN: We now have a public hearing regarding the Verizon Cable Franchise Agreement. The purpose of the Agreement is to get comments and review any past performance issues.

SOLICITOR HARPER: At this time, I would like to call the public hearing to order.

SOLICITOR HARPER: There is an exhibit to mark. Exhibit B1 proof that the hearing was advertised in the North Penn Reporter.

PRESIDENT JOHN WEIERMAN: Any comments on the above-mentioned items from the public?

STEVE BOWERS (510 W. VINE STREET): There is a pole outside my residence on W. Vine Street in need of replacement as it was hit by a car last week.

MANAGER DEFINIS: That pole was replaced this week and that pole was a Borough owned pole and is not a Verizon issue.

STEVE BOWERS: Thank you, I didn't know it was not a Verizon pole as Verizon poles in the past have taken longer to get replaced.

SOLICITOR HARPER: When a Borough pole is hit, the Borough tries hard to get the pole replaced as soon as possible and who ever hit the pole to pay for damages as it is expensive to pay for. If the Borough did not try and recoup the funds from the parties involved this could potentially raise the Borough rates but Manager DeFinis is good at completing this. If you see a pole hit, please contact the Borough with any information.

MANAGER DEFINIS: That pole hit was due to inclement weather.

PRESIDENT JOHN WEIERMAN: Any comments or questions from Council?

MANAGER DEFINIS: Jaime and I met with Verizon and the representative from Cohan to bring up issues collected over time such as distribution, correct Jaime?

ASSISTANT MANAGER JAIME SNYDER: Correct, as well as the locations of Verizon poles in the Borough that need replacement with a ranking of 1-10.

PRESIDENT JOHN WEIERMAN: Hearing no other comments or questions the hearing is closed.

4. PUBLIC INPUT: President Weierman asked if there was any Public Input.

Edward Smith of 29A Fretz Street, talking about telephone poles, if someone hits the pole do you go after them and the insurance company?

Councilmember Kroesser answered Yes.

Steve Bowers and his wife, Kelly of 510 W. Vine Street addressed Council asking if there was anything that could be done about the property adjacent to them due to the condition of the property and the falling trees into the residence. Mr. Bowers asked about a maintenance agreement with the developer as he knows there is a lawn cutting agreement. Mr. Bowers added that he appreciated the Borough helping out with the racoon issue a few weeks prior.

Councilmember Kroesser stated that he believed the tree on the property was removed from the house and Manager DeFinis added that Code Enforcement has been made aware of the property condition. Manager DeFinis added that he did contact the developer to discuss the condition of the property. Manager DeFinis added that the Borough will not review any items on this development until the escrow account is funded and the property condition is addressed.

Solicitor Harper stated that it may help if the Bowers contact the developer by email requesting him to clean up the property.

The Bowers thanked Borough Council for their attention to this matter.

as soon as she receives the lease, she will get it to Council as it must be considered by the end of May.

#### B. Bentwood Drive

Manager DeFinis received communication from the Bentwood Drive spokesperson and all residents have signed the release giving the Borough the right to dedicate the road. Manager DeFinis added that the only thing in the letter that was stated different then discussed was to have the residents at the end of the street have an input on the landscape.

Solicitor Harper stated that she can work on an Ordinance to dedicate the road but a small landscaping plan would be helpful if the Engineer could get that to Council.
