Ordinance 521

PROCEEDINGS

MR. WEIERMAN: We now have a public hearing regarding Ordinance number 521 Amending the Borough of Hatfield Code of Ordinances, Chapter 8 Titled "Floodplains" in its entirety and replacing it with a new Chapter 8 titled "Floodplain Management."

PATRICK HITCHENS, ESQ: At this time I would like to call the public hearing to order.

PATRICK HITCHENS, ESQ: Please let me mark some documents. The first document, B-1 is a copy of the entire Ordinance titled An Ordinance amending the Borough of Hatfield Code of Ordinances, Chapter 8 Titled "Floodplains" in its entirety and replacing it with a new Chapter 8 titled "Floodplain Management" and I did mark the document with number 521 in accordance with the Ordinance number. The second document, B-2 would be a copy of the legal notices advertised on February 2, 2016 and the second on February 9, 2016. I would also like to mark as B-3 a larger version of the Ordinance summary. I would like to mark as B-4 the document, letter with an attachment from FEMA Review Check List dated October 2014 and this is a review letter that the Borough had received dated February 16, 2016 stating that the proposed Ordinance under consideration this evening has been approved by FEMA and complies with their check list.

PATRICK HITCHENS, ESQ: Let the minutes reflect that there are no members of the public in attendance.

PATRICK HITCHENS, ESQ: This Ordinance is required by the county and required by FEMA and it is important that the Borough had passed an Ordinance allowing residents to receive flood insurance. The Borough's proposed Ordinance is essentially a copy of the model Ordinance proposed by the County with minor revisions from Bursich, the Borough Engineer and the Solicitors Office. Having noted in B-4 this does meet all the qualifications from FEMA.

PATRICK HITCHES, ESQ: Are there any questions or comments?

MR. FARRALL: When we initially sent this out for review did we receive any comments back?

PATRICK HITCHENS, ESQ: Yes, the process was we were supposed to send it to the County for review and after the County it would go to DCED for review then once DCED approved it would be adopted and sent to FEMA for review. We received a response from County with approval, then we sent it to DCED and at our last meeting we did not receive a response from DCED but we decided to move forward because of the time frame. Since that meeting we have received review from DCED stating we are in full compliance. Assuming it is approved tonight the Borough Manager will then send a copy to FEMA showing the adoption.

MR. FARRALL: For the record, this does not change any floodplain lines, it is just procedural?

MANAGER DEFINIS: Floodplain lines are decided and drawn by FEMA they were addressed through this process with a floodplain map.

MR. FARRALL: The Borough does not have anything to do with establishing these floodplain lines correct?

PATRICK HITCHENS, ESQ: That is correct.

MR. FARRALL: I just wanted this on record that we did not create or revise the lines, this is done by FEMA we are just amending the procedures.

PATRICK HITCHENS ESQ: That is correct. FEMA decides what properties fall under the floodplain. All we are asked to do is set rules for those who fall in that area to abide by for flood insurance. You are correct; the Borough is not responsible for deciding what properties fall in or not in the floodplain.

PATRICK HITCHENS ESQ: If there is no further discussion on this Ordinance I would like to call the hearing to a close and note that the Borough will be voting on this Ordinance later this evening.
