Chapter 24, Part 8, Section 204(D) of the "Hatfield Borough Code of Ordinances" requires all individual residents over eighteen (18) years of age or whoever has not previously registered shall, within fifteen (15) days of attaining such age, register with the Earned Income Tax Collector his name, address and other such information. 


